Dear Customer,

CCV GmbH is aware of its responsibility based on the obligations arising from the REACH Regulation and has implemented appropriate measures to ensure compliance.

- We obtain written confirmation from all relevant EU suppliers that no SVHC (substance of very high concern) substances >0.1% by weight is contained in the products supplied.
- We conclude separate contracts with all non-EU suppliers of articles. In these contracts, we are
  assured in writing that we will be informed immediately if the threshold value of 0.1% by weight for
  an SVHC substance in a product supplied to us is exceeded.
- CCV GmbH will continue to monitor the regulatory requirements related to chemical substances and will update this document should the need arise.

### REACH Regulation (EC) 1907/2006 Article 33

In accordance with Regulation (EC) 1907/2006 Article 33 ("REACH"), we have information obligations for articles when a SVHC listed substance is present in a concentration > 0.1% in one of our product components.
